主旨：茲通知本公司總代理之「柏瑞環球基金-柏瑞印度股票基金」(下稱「本
基金」)之淨值計算錯誤及補償事宜，詳後說明，請 查照。

說明：

一、本公司於 2020 年 9 月 28 日接獲境外基金機構通知，本基金發生淨值計算
錯誤之情事，其受影響期間及後續補償說明如下：

(一) 受影響基金：柏瑞環球基金-柏瑞印度股票基金 A，明細如下：

(二) 受影響區間:2019 年 5 月 31 日至 2020 年 2 月 27 日之區間共 55 個營
業日(下稱「受影響日」)，淨值前後更正對照表如附件一。

(三) 本事件係肇因於本基金之行政代理機構 State Street Fund Services
(Ireland) Limited(下稱「道富」)就印度資本利得稅 (CGT) 應計部
分於基金淨值評價程序中之計算處理不正確，導致淨值於受影響日
發生計算錯誤，致每單位淨值調整約 0.5%~0.6%，已超過基金註冊
地愛爾蘭法規所定之可容忍範圍。就本件淨值計算錯誤事宜，境外
基金機構已於 109 年 9 月 3 日 (愛爾蘭時間) 向基金註冊地主管機
關愛爾蘭中央銀行申報。本公司就前述事項亦已依法完成公告並向
金融監督管理委員會申報。

(四) 補償措施：除已於 2020 年 6 月 19 日更正該等錯誤外，境外基金機構
並責成道富就本基金過往的處理程序進行了全面性之檢視，道富同
意，將依據基金註冊地愛爾蘭之法規，對於前開於受影響日進行交易

之基金單位持有人進行補償，且將補償本基金與該等受影響之基金單位持有人。有關該等淨值錯誤作業之所有成本亦將由道富負責補償。境外基金機構偕同道富已對該受影響之銷售機構，於 2020 年 9 月 25 日進行補償作業，以確保投資人之權益。

- 二、本公司將依境外基金機構之補償措施辦理，即按有利於投資人之方式，對於投資人在受影響日當日有交易者，後續處理措施如下：
- (一) 對於受影響日淨值遭高估當日辦理申購或轉入之所有投資人，將依更正前後之單位數差額，補回至投資人帳戶內。
 - (二) 對於受影響日淨值當日遭高估辦理買回或轉出之所有投資人：買回款計算對投資人有利，不做調整。
- 三、已於 109 年 9 月 25 日完成後續補償作業如附件。

Dear Investor,

PineBridge India Equity Fund – Incorrect calculation of Capital Gain Tax

At PineBridge, we are committed to delivering excellence and working in the best interest of our clients. Regrettably, on this occasion we are writing to advise you, that it has come to our attention that the Administrative Agent, State Street Fund Services (Ireland) Limited, of the PineBridge India Equity fund (Sub-Fund) in which you are invested, incorrectly calculated a Capital Gains Tax (CGT) accrual.

Overview of the Issue

The CGT accrual was incorrectly applied and as a result, the Sub-Fund accrued for a lower CGT figure than should have been reflected in its net asset value. On a number of occasions the error was material in size (greater than 50bps) and a number of subscription, redemption and switch trades made during this period, from April 1 2018 to June 18 2020, were affected accordingly.

When was the error identified and corrected?

The incorrect calculation was identified by the Administrative Agent during the implementation of a new system to calculate CGT. The incorrect accrual has been rectified since June 19, 2020 and the Administrative Agent has since installed error-mitigating internal controls to prevent a reoccurrence.

What is the impact to my investment?

The value of the Sub-Fund was corrected. Where any subscriptions, transfers or redemptions did take place during the period of the material misallocation, the transactions were re-calculated and the resulting differences form the below compensation amounts.

What compensation is available?

In accordance with applicable regulatory and industry requirements, you will be compensated for the trades affected by materiality made by you during the period from April 1 2018 to June 18 2020. The Administrative Agent has calculated the compensation for the affected subscription, redemption and switch trades based on what the Sub-Fund's net asset value should have been, had the allocation of CGT been carried out correctly.

Units will be purchased on your behalf and a contract note will be issued confirming these details. The required transactions will be processed on or before 30 September 2020.
